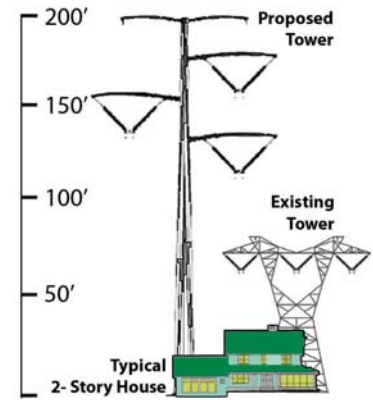


Tower #51 / 1
